AN ORDINANCE TO AMEND THE 2021 BUDGET FOR LEGAL SERVICES IN THE LAW DEPARTMENT

WHEREAS, the Comptroller of the City of Binghamton finds it proper and necessary to amend the 2021 budget for legal services in the Law Department; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on October 20, 2021.
