AN ORDINANCE TO AMEND THE 2021
INSURANCE FUND BUDGET FOR LEGAL
SERVICES IN RISK MANAGEMENT

WHEREAS, the Comptroller of the City of Binghamton finds it proper and necessary to amend the 2021 Insurance Fund budget for legal services in Risk Management; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on October 20, 2021.


NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2021 Insurance Fund budget for legal services in Risk Management as follows:

- (i) \$100,000 decrease the Insurance Fund Balance
- (ii) \$100,000 increase expense budget line M1910.54430 (Legal Services)

Section 2. That this Ordinance shall take effect immediately.
