**AN ORDINANCE TO AMEND THE 2021 PARKS  
BUDGET FOR MAINTENANCE AT FAIRVIEW  
PARK**

WHEREAS, the Comptroller of the City of Binghamton finds it proper and necessary to amend the 2021 Parks budget to transfer \$11,527.98 from Contingency for Fairview Park; and

WHEREAS, such budget amendment was approved by the Board of Estimate and Apportionment on October 20, 2021.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2021 Parks budget to transfer \$11,527.98 from Contingency for Fairview Park as follows:

Transfer From (Decrease):

\$11,527.98 A1910.55000 (Contingency)

Transfer To (Increase):

\$11,527.98 A7110.54640 (Parks Improv. & Maint.)

Section 2. That this Ordinance shall take effect immediately.
