A RESOLUTION AUTHORIZING THE CITY OF BINGHAMTON TO RENEW THE CONTRACT WITH THE BROOME COUNTY FRONT STREET DOG SHELTER FOR DOG SHELTER SERVICES

WHEREAS, the City of Binghamton provides dog control services within City limits; and WHEREAS, the City seizes dogs in accordance with Article 7 of the Agriculture and Markets law; and

WHEREAS, the City wishes to renew the contract with the Broome County Front Street Dog Shelter for dog shelter services for five (5) years, from January 1, 2022, through December 31, 2027; and

WHEREAS, this agreement may be terminated for any reason by either party as of the end of any calendar year by delivering written notice to the other party by June of the prior year before date of termination; and

WHEREAS, the cost for such services is an amount up to \$63,578.02 in 2022, and will increase by CPI each year.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor, or his designee, is authorized to enter into an agreement, approved as to form and content by the Office of Corporation Counsel, with the Broome County Front Street Dog Shelter for a period of five (5) years, from January 1, 2022, through December 31, 2027, and that the cost for such services is an amount up to \$63,578.02 in 2022, and will increase by CPI each year; and that funds shall be deducted from budget line A3510.54442 (Front Street Dog Shelter) for this purpose.
