A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH NYSDOT FOR THE HAWLEY STREET/WASHINGTON STREET TRAFFIC SIGNAL UPGRADE, PIN 9754.87

WHEREAS, the City of Binghamton wishes to enter into an agreement with New York State Department of Transportation ("NYSDOT") for the Hawley Street/Washington Street Traffic Signal Upgrade, PIN 9754.87 for construction, construction support and construction inspection; and

WHEREAS, the estimated cost for such services is not to exceed \$766,453; and

WHEREAS, the City will be reimbursed (i) 80% of \$571,000 (\$456,800) with Federal funds and (ii) 15% of \$571,000 (\$85,650) with State Marchiselli funds; and

WHEREAS, the remaining balance of \$224,003 must be funded 100% by the City; and WHEREAS, the City of Binghamton desires to advance the Project by making a commitment of 100% of the total cost of the Project, \$766,453, pending reimbursement.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor, or his designee, is authorized to enter into an agreement, approved as to form and content by the Office of Corporation Counsel, with NYSDOT for the Hawley Street/Washington Street Traffic Signal Upgrade, PIN 9754.87, at a cost not to exceed \$766,453, and pending reimbursement and for the City's share, funds will be deducted from H1650.525323.20619 (Hawley/Wash Traffic Signal) for this purpose.
