#### Esteemed City Council members,

I am reaching out to you today to have a concern addressed.

My name is Erin Alexander, and I have been a resident of this city for around 30 years. I am a transgender rights activist, and have gone to area schools to provide faculty training on creating a welcoming and supportive atmosphere for our area's LGBT students, as well as have had direct input on GENDA (gender expression non-discrimination act) at the time it was being written, at the request of the governor's office in Albany.

Over the past 2 years, I have unfortunately been forced to have negative interactions with this city's police department, which occurred because of John Barry, the Executive Director of Southern Tier AIDS Program. Mr Barry has repeatedly stalked my social media, and has several times sent officers from the Binghamton Police Department to my home in order to threaten me and force me to remove statements I had made from my social media, under threat of police violence, regarding his treatment of me and actions, all of which were not public facing - rather, visible solely to a limited audience, of which he was not a member. This in itself indicates Mr Barry has enlisted others to keep tabs on me, and it is of great concern to me that he is utilizing this community's emergency services to accomplish this goal.

In the last such occurrence, during which an armed police officer appeared at my home's door to demand I remove a statement I had made that Mr Barry has been threatening me by using the police, I told the officer that if that was the case, he also needed to visit Mr Barry regarding the very real crime of stalking and harassing members of this community, which was dismissed immediately by the officer as "that's a civil matter". If so, then WHY are they not telling Mr Barry the very same thing? What special privileges or office elevates him above the other members of this community, and allows him to violate our civil rights on a whim?

I am asking this body for a few minor things to address the issue:

- The permanent suspension of Mr Barry's and STAPs ability to call the police and send them anywhere in this city \*other\* than to one of their offices, to address safety concerns with staff there, just like any other business that is running in this area is expected to do
- An audit of calls and reports made to Binghamton Police Department by STAP staff, especially Mr Barry, to determine the extent to which STAP abuses their access to emergency services
- That the city recoup losses, should they deem fit, from STAP for utilizing the police department as their private security force, based on the aforementioned audit
- Punitive suspension of Southern Tier AIDS Program's license to operate in Binghamton until they can certify that they have corrected their internal issues
- A refresher for the officers serving our community on civil rights and what constitutes a valid emergency versus a civil issue that should be mediated elsewhere.

I feel these are reasonable and fair requests, and necessary for not only myself, but also those who do not have the means, safety, and visibility themselves to address it, yet have also been impacted by Mr Barry's such actions in the past. I thank you for your service to our community, and the attention to this matter.
