CAPITAL FUND BUDGET TO CLOSE THE 2017

WHEREAS, the Comptroller of the City of Binghamton finds it proper and necessary to amend the 2021 Capital Fund budget to close the 2017 Explosive Detective Canine Grant lines; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on November 3, 2021.


NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2021 Capital Fund budget to close 2017 Explosive Detective Canine Grant lines as follows:

- (i) \$2,249.00 decrease revenue budget line H.44389.P0060 (Fed.Aid.-17 Expdet. Canine Grant)
- (ii) \$2,249.00 decrease expense budget line H3120.555555.P0060 (17 Expdet. Canine Grant)

Section 2. That this ordinance shall take effect immediately.
