## **ORDINANCE**

entitled

AN ORDINANCE TO ALLOCATE AMERICAN RESCUE PLAN ACT FUNDS FOR TOURISM, CITY MARKETING, AND PROMOTIONS

WHEREAS, the Mayor and the Comptroller of the City of Binghamton find it proper and necessary to (i) create an expense budget line for tourism, City marketing, and promotions and (ii) allocate American Rescue Plan Act (ARPA) funds in the amount of \$200,000 for same; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on November 3, 2021.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

- Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to (i) create an expense budget line for tourism, City marketing, and promotions and (ii) allocate the American Rescue Plan Act (ARPA) funds in the amount of \$200,000 for same as follows:
  - (i) \$200,000 increase revenue budget line A.44089.F0015 (Federal Aid Stimulus)
  - (ii) \$200,000 increase expense budget line A6989.54742.F0015 (Tourism/Marketing/ Promotions ARPA)

Section 2. That this ordinance shall take effect immediately.
