**AN ORDINANCE TO AMEND THE 2021
BUDGET TO FUND DEMOLITION OF
BLIGHTED PROPERTIES**

WHEREAS, the City Engineer and Comptroller of the City of Binghamton find it proper and necessary to amend the 2021 budget to fund demolition of blighted properties at 74 Front St., 34 Burr Ave., and 39 Gerard Ave.; and

WHEREAS, such budget amendment was approved by the Board of Estimate and Apportionment on November 3, 2021.


NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2021 budget to fund demolition of blighted properties at 74 Front St., 34 Burr Ave., and 39 Gerard Ave. as follows:

- (i) \$85,000 increase revenue budget line A.42680 (Insurance Recovery)
- (ii) \$85,000 increase expense budget line A9950.59000 (Transfer to Capital)
- (iii) \$85,000 increase revenue budget line H.43051 (Interfund Transfer)
- (iv) \$85,000 increase expense budget line H1364.54470 (Demolition)

Section 2. That this ordinance shall take effect immediately.
