AN ORDINANCE TO AMEND THE 2021 CAPITAL BUDGET TO ALLOCATE AMERICAN RESCUE PLAN ACT FUNDS FOR WATER AND SEWER LINE IMPROVEMENTS

WHEREAS, the Mayor and the Comptroller of the City of Binghamton find it proper and necessary to amend the 2021 budget to (i) create expense budget lines in the 2021 Capital budget for the water and sewer line improvements and (ii) allocate American Rescue Plan Act (ARPA) funds in the amount of \$2,750,000 for same; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on November 3, 2021.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2021 budget to (i) create expense Capital budget lines for the water and sewer line improvements and (ii) allocate American Rescue Plan Act (ARPA) funds in the amount of \$2,750,000 for same as follows:

- (i) \$2,750,000 increase revenue budget line A.44089.F0015 (Fed.Aid-Stimulus)
- (ii) \$2,750,000 increase expense budget line A9950.59000.F0015 (Trans.Cap.ARPA)
- (iii) \$2,750,000 increase expense budget line H45031.F0015 (Interfund Trans.ARPA)
- (iv) \$2,000,000 increase expense budget line H8120.525055.F0015 (Sewer Lines)
- (v) \$ 750,000 increase expense budget line H8320.525058.F0015 (Water Lines)

Section 2. That this ordinance shall take effect immediately.
