A RESOLUTION TO ACCEPT \$50,000 FROM

THE NYS DCJS ANTI-GUN VIOLENCE AWARD

WHEREAS, the City of Binghamton is eligible to receive a grant in the amount of \$50,000 from the NYS DCJS Anti-Gun Violence award; and

WHEREAS, the grant will be allocated to the Binghamton Housing Authority to support the Gang Prevention program and provide means to purchase security cameras, computers, printers and to support additional training and payroll for additional outreach; and

WHEREAS, there is no local match; that pending reimbursement, funding for the project shall be drawn from the general fund; that the Binghamton Housing Authority Contract Administrator will be the grant project manager; and that the anticipated date of project completion is March 31, 2022.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor, or his designee, is hereby authorized to execute any and all documents, approved as to form and content by the Office of Corporation Counsel, to accept a grant in the amount of \$50,000 from the NYS DCJS Anti-Gun Violence award to fund the Binghamton Housing Authority Gang Prevention program and to support means to purchase security cameras, computers, printers and to support additional training and payroll for additional outreach.
