FIRST ORDER OF BUSINESS: APPROVAL OF MINUTES:

SECOND ORDER OF BUSINESS: BID OPENING:

Bids were received for Binghamton Municipal Parking Garage Demolition and Temporary Parking. Four bids were received, were read and were forwarded to Engineering on a motion by Mr. Seachrist and seconded by Mr. Maerkl and unanimously favored.

Bids were received for DECO District Streetscape Improvements – Phase 1 State Street. One bid was received, was read and was forwarded to Engineering on a motion by Mr. Shager and seconded by Mr. Maerkl and unanimously favored.

Bids were received for Replace the Vertical Pivot Gate at Central Garage. Two bids were received, were read and were forwarded to Department of Public Works on a motion by Mr. Seachrist and seconded by Mr. Shager and unanimously favored.

THIRD ORDER OF BUSINESS: RFP OPENING:
