AN ORDINANCE TO AMEND THE 2021 DPW
BUDGET FOR VARIOUS EXPENSES

WHEREAS, the Commissioner of DPW and the Comptroller of the City of Binghamton find it proper and necessary to amend the 2021 DPW budget for various expenses; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on December 22, 2021.


NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2021 DPW budget for various expenses as follows:
