**AN ORDINANCE TO AMEND THE 2021 DPW
BUDGET FOR OVERTIME**

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on December 22, 2021.

Transfer From (Decrease):


\$5,000 CL8160.51000 (Per.Ser.Laborer)
