ORDINANCE

AN ORDINANCE TO AMEND THE 2021 GENERAL FUND BUDGET TO TRANSFER \$7,000,000 TO THE PARKING RAMP RESERVE FUND

WHEREAS, the Council of the City of Binghamton adopted Permanent Ordinance 18-37, dated March 21, 2018, entitled "An Ordinance to Establish a Parking Ramps and Lots Reserve Fund in the amount of \$1,000,000"; and

WHEREAS, the Comptroller of the City of Binghamton finds it proper and necessary to amend the 2021 General Fund budget to transfer \$7,000,000 of General Fund balance to the Parking Ramp Reserve Fund for construction of the Water Street Parking Garage; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on December 22, 2021.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

- Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2021 General Fund budget to transfer \$7,000,000 of General Fund balance to the Parking Ramp Reserve Fund for construction of the Water Street Parking Garage as follows:
 - (i) \$7,000,000 decrease General Fund Balance
 - (ii) \$7,000,000 increase expense budget line A878B (Capital Reserve-Parking Ramps)

Section 2. That this Ordinance shall take effect immediately.
