AN ORDINANCE AMENDING THE 2021 BUDGET TO ALLOCATE AMERICAN RESCUE PLAN ACT FUNDS FOR PREMIUM PAY TO CSEA WORKERS

WHEREAS, the Mayor and the Comptroller of the City of Binghamton find it proper and necessary to amend the 2021 budget to (i) create an expense budget line for CSEA workers for premium pay and (ii) allocate American Rescue Plan Act (ARPA) funds in the amount of \$10,000 for same; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on December 22, 2021.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2021 budget (i) create expense budget line A1440.51000.F0015 (Premium Pay-CSEA) and (ii) allocate American Rescue Plan Act (ARPA) funds in the amount of \$10,000 for same as follows:

- (i) \$10,000 increase revenue budget line A.44089.F0015 (Fed.Aid-Other)
- (ii) \$10,000 increase expense budget line A1440.51000.F0015 (Premium Pay-CSEA)

Section 2. That this Ordinance shall take effect immediately.
