## RESOLUTION

A RESOLUTION AUTHORIZING THE MAYOR **AMEND** THE **AGREEMENT** GREATER OPPORTUNITIES FOR BROOME FOR USE OF FY46 CDBG FUNDING FOR CARPET REPLACEMENTS

WHEREAS, pursuant to Permanent Resolution 21-41, dated June 9, 2021, the City of Binghamton entered into an agreement with non-profit agencies for use of FY46 CDBG funds for capital projects; and

WHEREAS, the agreement with Greater Opportunities for Broome awarded FY46 CDBG funds in an amount not to exceed \$20,000 for siding improvements; and

WHEREAS, the HUD Manager recommends a change in scope of the agreement from siding improvements to carpet replacements.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor, or his designee, is hereby authorized to amend the agreement, approved as to form and content by the Office of Corporation Counsel, with Greater Opportunities for Broome to change the scope of the agreement from siding improvements to carpet replacements; and that this amendment does not change the total amount not to exceed \$20,000 and the funding source remains CD8662.533552.CDY46.
