## **ORDINANCE**

entitled

AN ORDINANCE TO ALLOCATE AMERICAN RESCUE PLAN ACT FUNDS FOR AFFORDABLE HOUSING AT THE TOWN AND COUNTRY APARTMENTS

WHEREAS, the Mayor and the Comptroller of the City of Binghamton find it proper and necessary to (i) create an expense budget line for Affordable Housing in the capital fund for improvments for qualified census track housing at the Town and County Apartments and (ii) allocate American Rescue Plan Act (ARPA) funds in the amount of \$3,000,000 for same; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on December 22, 2021.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

- Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to (i) create an expense budget line for Affordable Housing in the capital fund for improvments for qualified census track housing at the Town and County Apartments and (ii) allocate American Rescue Plan Act (ARPA) funds in the amount of \$3,000,000 for same as follows:
  - (i) \$3,000,000 increase expense budget line A9950.59000.F0015 (Trans.Cap.ARPA)
  - (ii) \$3,000,000 increase revenue budget line H.45031.F0015 (Interfund Trans.ARPA)
  - (iii) \$3,000,000 increase expense budget line H8686.54756.F0015 (Affordable Housing ARPA)

Section 2. That this ordinance shall take effect immediately.
