ORDINANCE

AN ORDINANCE TO ALLOCATE AMERICAN
RESCUE PLAN ACT FUNDS FOR THE YWCA
OF BINGHAMTON AND BROOME COUNTY
FOR THE DEVELOPMENT OF A NEW
CHILDCARE FACILITY

WHEREAS, the Mayor and Comptroller of the City of Binghamton find it proper and necessary to (i) create an expense budget line for development of a new childcare facility by the YWCA and (ii) allocate American Rescue Plan Act (ARPA) funds in the amount of \$500,000 for same; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on January 5, 2022.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to (i) create expense budget line A6055.52000 (YWCA Equipment & Capital Outlay) for development of a new childcare facility by the YWCA and (ii) allocate American Rescue Plan Act (ARPA) funds in the amount of \$500,000 for same as follows:

- (i) \$500,000 increase revenue budget line A.44089.F0015 (Federal Aid – Stimulus)
- (ii) \$500,000 increase expense budget line A6055.52000.F0015 (YWCA Equipment & Capital Outlay)

Section 2. That this ordinance shall take effect immediately.
