A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH STREETER **ASSOCIATES FOR** ORDER NO. 17 REGARDING THE BINGHAMTON-JOHNSON CITY **JOINT** SEWAGE TREATMENT FACILITIES

WHEREAS, the City of Binghamton contracted with Streeter Associates for the Binghamton-Johnson City Joint Sewage Treatment Facilities; and

WHEREAS, the City Engineer recommends the Mayor enter into an agreement with Streeter Associates Company for Change Order No. 17 at a cost of \$43,020, which exceeds 25% of the original contract price after approval of prior change orders, for site work and fine grading for the North and South area of the Treatment Facilities, seeding for the site work, and other work as required by the engineering specifications.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor, or his designee, is hereby authorized to enter into an agreement, approved as to form and content by the Office of Corporation Counsel, with Streeter Associates for Change Order No. 17 in an amount not to exceed \$43,020 for the Binghamton-Johnson City Joint Sewage Treatment Facilities; and that funds will be deducted from budget line HX8150.500200.J11NN (Construction Services-Non-Flood) for this purpose.
