AN ORDINANCE AUTHORIZING THE ABANDONMENT OF 75-77 GRISWOLD STREET AS PUBLIC PROPERTY

WHEREAS, General City Law § 20 authorizes a City to hold and administer real property; and

WHEREAS, the Council duly advertised and held a public hearing on February 9, 2022, regarding the abandonment of 75-77 Griswold Street as a City Street; and

WHEREAS, the Council has determined that 75-77 Griswold Street is no longer necessary for public use because it fronts on only two parcels, both of which have alternative access points to a public ROW, and it receives no through traffic and serves no purpose for the general public.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That 75-77 Griswold Street is no longer necessary for public use.

Section 2. That the Mayor and the Commissioner of Public Works are authorized to take the necessary action to properly discontinue 75-77 Griswold Street as a City Street, including a reservation of utility or other easements as may be deemed necessary.

Section 3. That this Ordinance shall take effect immediately.
