ORDINANCE

AN ORDINANCE TO AMEND THE 2022 LAW
AND RISK MANAGEMENT BUDGETS TO
INCREASE THE ANNUAL SALARY OF THE
ASSISTANT CORPORATION COUNSEL TO
\$60,000

WHEREAS, the Corporation Counsel and Comptroller of the City of Binghamton find it proper and necessary to amend the 2022 Law and Risk Management budgets to increase the annual salary of the Assistant Corporation Counsel position from \$58,000 to \$60,000; and

WHEREAS, there are sufficient funds in the existing budget lines because the position is currently vacant and will remain vacant until March, 2022; and


WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on February 23, 2022.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2022 Law budget to increase budget line A1420.51000 (Assistant Corporation Counsel -.50 @ \$58,000) and Risk Management budget line M1910.51000 (Assistant Corporation Counsel -.50 @ \$58,000) from \$58,000 to \$60,000.

Section 2. That this Ordinance shall take effect immediately.
