## **ORDINANCE**

entitled

AN ORDINANCE TO AMEND THE 2021 GENERAL FUND BUDGET TO PAY FOR CERTAIN EXPENSES AT MIRABITO STADIUM

WHEREAS, the City of Binghamton is responsible to pay for certain expenses at Mirabito Stadium (fromally known as NYSEG Stadium) that the Binghamton Urban Reneal Agency (BURA) is unable to pay; and

WHEREAS, the Comptroller of the City of Binghamton finds it proper and necessary to amend the 2021 General Fund budget to pay for such expenses; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on February 23, 2022.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

- Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2021 General Fund budget to fund BURA to cover operational expenses at Mirabito Stadium as follows:
  - (i) \$33,000 increase expense budget line A9950.59000 (Transfer to Capital)
  - (ii) \$33,000 decrease expense budget line A1990.55000 (Contingency)
  - (iii) \$33,000 increase revenue budget line H.45031 (Interfund Transfer)
  - (iv) \$33,000 increase expense budget line H.1310.525209 (Mirabito Stadium Improv.)

Section 2. That this Ordinance shall take effect immediately.
