AN ORDINANCE TO AMEND THE 2021 BINGHAMTON-JOHNSON CITY JOINT SEWAGE BOARD BUDGET TO TRANSFER FUNDS FOR GAS/DIESEL AND EQUIPMENT & PUMP REPAIRS

WHEREAS, the City of Binghamton (the "City") is a joint owner of the Binghamton-Johnson City Joint Sewage Treatment Facilities (the "BJCJSTF") with the Village of Johnson City (the "Village"); and

WHEREAS, the BJCJSTF is operated and maintained by the Binghamton-Johnson City Joint Sewage Board (the "JSB") under a series of inter-municipal agreements between the City and the Village; and

WHEREAS, the Council of the City and the Board of Trustees of the Village approve the BJCJSTF budget; and

WHEREAS, the JSB has requested an amendment to the 2021 BJCJSTF budget to increase the annual appropriations for Gas/Diesel by \$3,200, increase Equipment and Pump Repairs by \$4,800 and increase Equipment and Pump Repairs – Electrical by \$1,500 with the corresponding amount of \$9,500 taken from the Reimburse City Local Costs expense line.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Council approves and directs the Comptroller/JSB Fiscal Officer to amend and make journal budget entries in the 2021 BJCJSTF budget to adjust the Aappropriations for Gas/Diesel from \$15,000 to \$18,200, Equip. & Pump Repair \$98,453 to \$103,253 and Equip. & Pump Repairs – Electrical from \$60,000 to \$61,500 as follows:
