WHEREAS, pursuant to Permanent Resolution 19-68, dated August 21, 2019, the City entered into an Inter-municipal Agreement with Broome County for operation of the First Ward Senior Center kitchen for the County sponsored Senior Citizen Meal Program; and

WHEREAS, pursuant to Permanent Resolution 19-121, dated December 18, 2019; and Permanent Resolution 21-10, dated February 17, 2021, the City extended the contract with Broome County for operation of the First Ward Senior Center kitchen for the County sponsored Senior Citizen Meal Program; and

WHEREAS, the City wishes to extend the operating agreement to December 31, 2022.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor of the City of Binghamton, or his designee, is hereby authorized to extend the Inter-municipal Agreement, approved as to form and content by the Office of Corporation Counsel, with Broome County for operation of the First Ward Senior Center kitchen for the County sponsored Senior Citizen Meal Program through December 31, 2022.
