1. Project Address or Intersection: 23 College Street

Applicant: Mr. DiRosa

Requested Review: Request for No Parking

Traffic Division and Cindy Paddick responded to this location. Upon surveying the area, we spoke with the applicant who states that due to his driveway abutting the intersection, and parents parking to pick up their children from school up the street, his vision is obstructed when backing out. His line of sight is further obstructed by the students and school bus traffic. The Traffic Division feels that the request is warranted and that code be amended as follows:

INSERT: Section 23 No Parking Anytime

College Street-South Side-Beginning at a point of 30 feet east of the north east extended curb line of Clarke Street and ending at 55 ft. west of said point.

State Street-East Side-from 170 feet south of Hawley Street to 405 feet south.

INSERT: Section 23.1 No Standing Anytime

State Street-East Side-from 170 feet south of Hawley Street to 281 feet south. State Street-East Side-from 361 feet south of Hawley Street to 405 feet south.

INSERT: Section 23.4 No Parking Except for City of Binghamton Vehicles (CAC Only)

State Street-East Side Only-from 281 feet south to 361 feet south.

Requested Review: 2 Side Parking

The Traffic Division and BMTS, after reviewing a request to insert parking on both sides of State Street, From Henry Street to Lewis Street; presently only on the east side of that streets, recommend that it be denied. State Street is a heavily travelled through street and with the width of the roadway being less than the suggest 37' width, it apprears it could create congestion. There are also several driveway accesses to buildings on the west side as the street whose line of sight could be obstructed with parked vehicles.
