1. Project Address or Intersection: 241 Robinson Street

Requested Review: Relocate Driveway Curb Cut on the east side of property to the west side.

Gerald J. Goff, 56 Lakeview Terrace, submitted a Traffic Board Application to the Traffic Board for the on August 8, 2021 requesting that a driveway curb cut on the west side of his property, 241 Robinson Street, that he shares with 239 Robinson Street, be reinserted. Mr. Goff stated that the apron was removed during the reconstruction of Robinson Street, when the owners of 239 Robinson Street had that curb cut moved from the east side of their address to the west side of the property. The Traffic Division, upon following up on the request, found that 241 Robinson Street had an existing driveway cut on the east side of that address.

Upon reviewing the request with the planning and engineers' offices, it found that the original driveway cut between those two addresses was for 239 Robinson Street, only. The owner of 239 Robinson Street stated that at some point when 239 was vacant, and before it was purchased at auction, a property line fence was removed and an abutting driveway was installed at 241 Robinson Street. After reviewing the schematics with the Planning Department and Engineers' Office, the Traffic Division recommends that this request be denied.

INSERT: Section 18.1 - Trucks Over five tons prohibited: Lockwood Street – From Chenango Street to Westview Terrace. Westview Terrace – From Lockwood Street to Green Street.
