Introductory Ordinance 22-40. Considered in Finance: Scaringi

An Ordinance amending the Bond Ordinance adopted February 6, 2019 and previously amended on May 19, 2021, on account of the Pedestrian Safety Improvements

Motion to declare a Type II action under SEQRA for the following reasons:

<u>Nature of action.</u> An ordinance to modify the February 6, 2019, bond, as previously modified on May 19, 2021, to increase the appropriation for pedestrian improvements from \$489,300 to \$850,000 and to further amend said bond ordinance to authorize the issuance of an additional \$360,700 bonds to finance said increased appropriation.

<u>Findings.</u> The City of Binghamton City Council has determined that the proposed action described above is a Type II action based on §617.5 Type II C, (4) repaving of existing highways not involving the addition of new travel lanes, (5) street openings and right-of-way openings for the purpose of repair or maintenance of existing utility facilities, and (21) minor temporary uses of land having negligible or no permanent impact on the environment; and no further environmental review is necessary.
