WHEREAS, pursuant to Permeant Resolution 10-48, dated May 19, 2010, City Council established "Smoke Free Parks" in the City of Binghamton; and

WHEREAS, the City wishes to confirm that all City parks, playgrounds and recreational facilities (including park parking lots) are tobacco and smoke free zones including e-cigarettes and marijuana; and

WHEREAS, this Resolution does not apply to Ely Park Golf Course that is operated by a third party; and

WHEREAS, the Council of the City of Binghamton wishes to support this effort to the general health of its residents, to protect park users, and to protect and keep parks clean.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that all City parks, playgrounds, and recreational facilities (including park parking lots) located within the City of Binghamton, except Ely Park Golf Course, are tobacco and smoke free zones including e-cigarettes and marijuana, and that appropriate signage may be posted by the Commissioner of Parks and Recreation; and be it further
