AN ORDINANCE TO AMEND THE 2022 BUREAU OF POLICE BUDGET TO INCREASE THE ANNUAL SALARY OF THE SENIOR CRIME ANALYST TO \$72,000

WHEREAS, pursuant to Permanent Resolution 21-75, dated September 22, 2021, City Council approved acceptance of the Gun Involved Violence Elimination (GIVE) grant in an effort to stop violent crime, targeting firearm related crime, and aggravated assults, as well as fund aspects of the Southern Tier Crime Analyst Center (STCAC) including a Crime Analyst and BPD FIO investigator, and fund training expenses and overtime for crime reduction; and

WHEREAS, the Chief of Police and Comptroller of the City of Binghamton find it proper and necessary to amend the 2022 Bureau of Police budget to allocate funds from the GIVE grant to increase the annual salary of the Senior Crime Analyst from \$66,000 to \$72,000; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on March 9, 2022.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2022 Bureau of Police budget to increase the annual salary of the Senior Crime Analyst from \$66,000 to \$72,000; and to transfer funds from the GIVE grant to fund the increase as follows:
