AN ORDINANCE TO REPLACE PERMANENT ORDINANCE 22-39 TO AMEND THE FY47 CDBG BUDGET AND 2022 GENERAL FUND TO PURCHASE AND EQUIP A FIRE RESCUE TRUCK FOR THE BINGHAMTON FIRE DEPARTMENT

WHEREAS, pursuant to Permanent Ordinance 22-39, dated March 9, 2022, the Council of the City of Binghamton amended the FY47 CDBG budget to purchase and equip a fire rescue truck for the Binghamton Fire Department, and

WHEREAS, the Mayor and Comptroller of the City of Binghamton find it proper and necessary to replace Permanent Ordinance 22-39 to amend the FY47 CDBG budget and 2022 General Fund to purchase and equip a fire rescue truck for the Binghamton Fire Department; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on March 9, 2022.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

- Section 1. That Permanent Ordinance 22-39, dated March 9, 2022, is hereby declared null and void.
- Section 2. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the FY47 CDBG budget and 2022 General Fund to purchase and equip a fire rescue truck for the Binghamton Fire Department as follows:
 - (i) \$600,000 decrease expense budget line CD7310.533536.CDY47 (C.P. Improvements)
 - (ii) \$600,000 increase expense budget line CD3410.XXXXXX.CDY47 (Fire Equip.)
 - (iii) \$200,000 increase revenue budget line A.49999 (Fund Balance/Lost Revenue)
 - (iv) \$200,000 increase expense budget line A.3410.52XX (Fire Equip.)

Section 2. That this Ordinance shall take effect immediately.
