AN ORDINANCE TO AMEND THE 2022 BUDGET TO ALLOCATE AMERICAN RESCUE PLAN ACT FUNDS FOR DEMOLITION OF VACANT AND ABANDONED PROPERTIES

WHEREAS, the Mayor and Comptroller of the City of Binghamton find it proper and necessary to amend the 2022 budget to allocate American Rescue Plan Act (ARPA) funds for demolition of vacant and abandoned properties to promote neighborhood stabilization; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on March 9, 2022.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

- Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2022 budget to allocate American Rescue Plan Act (ARPA) funds for demolition of vacant and abandoned properties to promote neighborhood stabilization as follows:
 - (i) \$250,000 increase revenue budget line A.44089.F0015 (Fed.Aid-Other)
 - (ii) \$250,000 increase expense budget line A1364.54470.F0015 (Demolition-ARPA)

Section 2. That this Ordinance shall take effect immediately.
