AN ORDINANCE TO AMEND THE 2022 INSURANCE FUND TO INCREASE REVENUE AND EXPENSES FOR DAMAGE TO THE STATE STREET GARAGE ENTRY LANE EQUIPMENT

WHEREAS, the Comptroller of the City of Binghamton finds it proper and necessary to amend the 2022 Insurance Fund to increase revenue and expenses for damage to the State Street Garage entry lane equipment, pending insurance recoveries; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on March 23, 2022.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

- That the Comptroller and City Treasurer of the City of Binghamton are Section 1. hereby authorized and directed to amend the 2022 Insurance Fund to increase revenue and expenses for damage to the State Street Garage entry lane equipment, pending insurance recoveries as follows:
 - \$17,695 increase revenue budget line M.42680 (Insurance Recovery) (i)
 - \$17,695 increase expense budget line M1910.52600 (Equipment) (ii)

Section 2. That this Ordinance shall take effect immediately.
