AN ORDINANCE TO AMEND THE 2022 PERSONNEL AND CIVIL SERVICE BUDGET PROVIDE A RESPONSIBILITY ADJUSTMENT TO THE PROGRAM ASSISTANT DUE TO STAFF VACANCY

WHEREAS, the full time position of Assistant Director of Personnel and Safety in the Personnel Department has been vacant since December 2021; and

WHEREAS, the Program Assistant has and continues to perform many of the responsibilities of the Assistant Director of Personnel and Safety; and

WHEREAS, the City wishes to amend the 2022 Personnel and Civil Service budget to provide a responsibility adjustment to the Program Assistant in the amount of \$12,000 for these assumed responsibilities, with the undertstanding that said amount may be increased if the position of Assistant Director of Personnel and Safety continues to be vacant for an extended period of time; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on March 23, 2022.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2022 Personnel and Civil Service budget to (i) add budget line A1430.51000 (Responsibility Adjustment - Program Assistant) and (ii) transfer \$12,000 for these assumed responsibilities as follows:

Section 2. That the above responsibility adjustment will be equally divided and paid over the remaining pay periods in 2022.

Section 3. That this Ordinance shall take effect March 19, 2022.
