AN ORDINANCE TO AMEND THE 2022 MAYOR BUDGET TO ALLOCATE AMERICAN RESCUE PLAN ACT FUNDS TOWARD A COMMUNITY FOOD PANTRY

WHEREAS, the Mayor and Comptroller of the City of Binghamton find it proper and necessary to amend the 2022 Mayor budget to (i) create an expense budget line for Safety Net-Community Food Pantry, and (ii) allocate American Rescue Plan Act (ARPA) funds in the amount of \$30,000 for same; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on March 23, 2022.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

- Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to (i) amend the 2022 Mayor budget to create expense budget line A6140.XXXXX.F0015 (Safety Net-Community Food Pantry), and (ii) allocate American Rescue Plan Act (ARPA) funds in the amount of \$30,000 for same as follows:
 - (i) \$30,000 increase revenue budget line A.44089.F0015 (Federal Aid-Other)
 - (ii) \$30,000 increase expense budget line A6140.XXXXX.F0015 (Safety Net-Community Food Pantry)

Section 2. That this Ordinance shall take effect immediately.
