## **ORDINANCE**

entitled

AN ORDINANCE TO AMEND THE 2022 LAW BUDGET TO ALLOCATE AMERICAN RESCUE PLAN ACT FUNDS FOR A NEW ASSISTANT CORPORATION COUNSEL PROSECUTOR POSITION

WHEREAS, the Mayor and Comptroller of the City of Binghamton find it proper and necessary to (i) amend the 2022 Law budget to create an expense budget line for an Assistant Corporation Counsel Prosecutor position at an annual salary of \$80,000, together with benefits and related expenses, effective as of April 1, 2022, to support neighborhood stabilization efforts in distressed areas, and (ii) allocate American Rescue Plan Act (ARPA) funds in the amount of \$77,630 for same; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on March 23, 2022.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to (i) amend the 2022 Law budget to create expense budget line A1420.51000.F0015 (Per.Ser-Asst.Corp.Counsel) at an annual salary of \$80,000, together with benefits and related expenses, effective as of May 1, 2022, to support neighborhood stabilization efforts in distressed areas, and (ii) allocate American Rescue Plan Act (ARPA) funds in the amount of \$77,630 for same from May 1, 2022, to the end of the year as follows:

- (i) \$77,630 increase revenue budget line A.44089.F0015 (Federal Aid-ARPA)
- (ii) \$53,850 increase expense budget line A1420.51000.F0015 (Per.Ser-Asst. Corp.Counsel)
- (iii) \$ 5,115 increase expense budget line A9010.58000A.F0015 (NYS Retirement-ARPA)
- (iv) \$ 4,120 increase expense budget line A9030.58000B.F0015 (Social Security-ARPA)
- (v) \$14,545 increase expense budget line A9060.58000C.F0015 (Health Ins.-ARPA)
