## RESOLUTION

A RESOLUTION AUTHORIZING THE MAYOR TO AMEND THE AGREEMENT WITH GREATER OPPORTUNITIES FOR BROOME & CHENANGO, INC. FOR USE OF FY46 CDBG FUNDS FOR CAPITAL PROJECTS

WHEREAS, pursuant to Permanent Resolution 21-41, dated June 9, 2021, the City of Binghamton entered into an agreement with non-profit agencies for use of FY46 CDBG funds for capital projects; and

WHEREAS, the agreement with Greater Opportunities for Broome & Chenango, Inc. awarded FY46 CDBG funds in an amount not to exceed \$20,000 for an exterior refurbishing project at 5 West State Street; and

WHEREAS, the HUD Manager recommends a change in scope of the agreement from an exterior refurbishing project to a carpet replacement project 5 West State Street.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session does hereby:

RESOLVE that the Mayor of the City of Binghamton, or his designee, is hereby authorized to amend the agreement, approved as to form and content by the Office of Corporation Counsel, with Greater Opportunities for Broome & Chenango, Inc. for use of FY46 from an exterior refurbishing project to a carpet replacement project at 5 West State Street; and that this amendment does not change the total amount not to exceed \$20,000 and the funding source remains CD8662.533552.CDY46 (Human Services Capital Set Aside) for this purpose.
