A RESOLUTION AUTHORIZING THE MAYOR TO AMEND THE FY47 ANNUAL ACTION PLAN

WHEREAS, the Manager, HUD Administration and Housing, recommends amending the FY47 Annual Action Plan to accept \$300,000 in Revolving Loan funds from the Binghamton Local Development Corporation ("BLDC") as Community Development Block Grant ("CDBG") program income; and

WHEREAS, \$250,000 will be allocated for various economic activities and \$50,000 for historical preservation planning.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor of the City of Binghamton, or his designee, is hereby authorized to amend the FY47 Annual Action Plan, approved as to form and content by the Office of Corporation Counsel, to accept \$300,000 in Revolving Loan funds from the BLDC as CDBG program income (CD.42170); and that \$250,000 will be allocated to budget line CD6889.54000.CDY47 (Contractual) to be used for various economic activities, and that \$50,000 will be allocated to budget line CD8684.533532.CDY47 (Planning Services) for historical preservation planning.
