AN ORDINANCE TO AMEND THE 2022
INSURANCE FUND BUDGET TO INCREASE
REVENUE FOR AN ANTICIPATED
INSURANCE RECOVERY AND CREATE AN
EXPENSE LINE FOR AN EMERGENCY
DEMOLITION AT 159 CONKLIN AVENUE

WHEREAS, the Comptroller of the City of Binghamton finds it proper and necessary to amend the 2022 Insurance Fund budget to (i) increase revenue for an anticipated insurance recovery and (ii) create and fund a demolition expense line for an emergency demolition at 159 Conklin Avenue; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on May 18, 2022.


NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2022 Insurance Fund budget to (i) increase revenue for an anticipated insurance recovery; and (ii) create and fund a demolition expense line for an emergency demolition at 159 Conklin Avenue as follows:

- (i) \$106,580 increase revenue budget line M.42680 (Insurance Recovery)
- (ii) \$106,580 increase expense budget line M1910.54470 (Demolition)

Section 2. That this Ordinance shall take effect immediately.
