AN ORDINANCE TO AMEND THE 2022
BUDGET TO ALLOCATE AMERICAN RESCUE
PLAN ACT FUNDS TO SUPPORT GUN
VIOLENCE REDUCTION PROGRAMS
THROUGH THE SOUTHERN TIER CRIME
ANALYSIS CENTER

WHEREAS, the Mayor and Comptroller of the City of Binghamton find it proper and necessary to amend the 2022 budget to (i) create a new expense budget line to support gun violence reduction programs through the Southern Tier Crime Analysis Center and (ii) allocate American Rescue Plan Act (ARPA) funds to in an amount not to exceed \$1,000,000 for same; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on May 18, 2022.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2022 budget to (i) create a new expense budget line H.3120.XXXXX.F0015 (ARPA Gun Violence) to support gun violence reduction programs through the Southern Tier Crime Analysis Center and (ii) allocate American Rescue Plan Act (ARPA) funds to in an amount not to exceed \$1,000,000 as follows:

- (i) \$1,000,000 increase expense budget line A9950.59000.F0015 (Interfund Transfer-ARPA)
- (ii) \$1,000,000 increase revenue budget line A.44089.F0015 (Federal Aid-Other)
- (iii) \$1,000,000 increase revenue budget line H.45031.F0015 (Interfund Transfer-ARPA)
- (iv) \$1,000,000 increase expense budget line H.3120.XXXXX.F0015 (ARPA Gun Violence)

Section 2. That this Ordinance shall take effect immediately.
