AN ORDINANCE TO AMEND THE 2022 GOLF FUND BUDGET TO PAY THE LEASE ON GOLF EQUIPMENT

WHEREAS, the Comptroller of the City of Binghamton finds it proper and necessary to amend the 2022 Golf Fund budget to pay the lease on golf equipment; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on June 22, 2022.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2022 Golf Fund budget to pay the lease on golf equipment as follows:
