## **ORDINANCE**

entitled

AN ORDINANCE TO AMEND THE 2022 FINANCE BUDGET INCREASE THE SALARY OF THE PAYROLL ASSISTANT

WHEREAS, the Comptroller of the City of Binghamton finds it proper and necessary to amend the 2022 Finance budget to increase the annual salary of the Payroll Assistant; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on June 22, 2022.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2022 Finance budget to (i) increase the annual salary of the Payroll Assistant from \$36,671 to \$37,350; and (ii) transfer funds to pay for same from June 25, 2022 to December 31, 2022, as follows:
