AN ORDINANCE TO AMEND THE 2022
ASSESSOR BUDGET TO PURCHASE

WHEREAS, the Assessor and Comptroller of the City of Binghamton find it proper and necessary to amend the 2022 Assessment budget to purchase furniture/storage for files in the Assessor's office; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on June 22, 2022.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2022 Assessment budget to purchase furniture/storage for files in the Assessor's office as follows:

Transfer From (Decrease):

\$7,500 A1355.54426 (Appraisal Ser.)

Transfer To (Increase):

\$7,500 A1310.52200 (Furniture)

Section 2. That this Ordinance shall take effect immediately.
