AN ORDINANCE TO AMEND CHAPTER 124-39,
PERSONNEL POLICIES, OF THE CODE OF THE
CITY OF BINGHAMTON, TO ADD THE
DIRECTOR OF PLANNING, HOUSING, AND
COMMUNITY DEVELOPMENT AND
ASSISTANT DIRECTOR OF PLANNING,
HOUSING, AND COMMUNITY
DEVELOPMENT TO THE LIST OF 8 HOUR PER
STANDARD WORK DAY EMPLOYEES

WHEREAS, the Council of the City of Binghamton wishes to amend the Code of the City of Binghamton, Chapter 124, *Personnel Policies*, Article VIII, *Officers and Employees not covered by Collective Bargaining Agreements*, §124-39.A, *Standard Work Day*, to add the Director of Planning, Housing, and Community Development and the Assistant Director of Planning, Housing, and Community Development.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Code of the City of Binghamton, Chapter 124, *Personnel Policies*, Article VIII, *Officers and Employees not covered by Collective Bargaining Agreements*, §124-39.A, *Standard Work Day*, is hereby amended to add to the list of 8 hour per standard work day employees as follows:

- X. Director of Planning, Housing, and Community Development
- Y. Assistant Director of Planning, Housing, and Community Development

Section 2. That this Ordinance shall take effect June 25, 2022.
