## **ORDINANCE**

entitled

AN ORDINANCE TO AMEND THE 2022 PLANNING AND CONTINGENCY BUDGETS INCREASE THE SALARY OF DIRECTOR OF PLANNING, HOUSING, AND COMMUNITY **DEVELOPMENT** AND ASSISTANT DIRECTOR OF PLANNING. HOUSING, AND **COMMUNITY** DEVELOPMENT

WHEREAS, the Mayor and Comptroller of the City of Binghamton find it proper and necessary to amend the 2022 Planning and Zoning budget and the 2022 Contingency budget to increase the annual salary of the Director of Planning, Housing, and Community Development and the Assistant Director of Planning, Housing, and Community Development based on an 8 hour standard work day; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on June 22, 2022.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2022 Planning and Zoning budget and the 2022 Contingency budget to (i) increase the annual salary of the Director of Planning, Housing, and Community Development from \$63,578 to \$74,397; (ii) increase the annual salary of the Assistant Director of Planning, Housing, and Community Development from \$59,883 to \$70,829; and (iii) transfer funds to pay for same from June 25, 2022, to December 31, 2022, as follows:
