AN ORDINANCE TO AMEND THE 2022 BUDGET TO ALLOCATE AMERICAN RESCUE PLAN ACT FUNDS TO SUPPORT FIRE STATION FACILITY REHABILITATIONS

WHEREAS, the Fire Chief and Comptroller of the City of Binghamton find it proper and necessary to amend the 2022 budget to (i) create a new budget line for Fire Station Capital; and (ii) allocate American Rescue Plant Act (ARPA) funds in an amount not to exceed \$1,000,000 for same; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on July 6, 2022.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2022 budget to (i) create new budget line H3410.XXXXXX.F0015 (Fire Station Capital) for fire station facility rehabilitations; and (ii) allocate ARPA funds in an amount not to exceed \$1,000,000 as follows:

- (i) \$1,000,000 increase revenue budget line A.44089.F0015 (Fed.Aid-ARPA)
- (ii) \$1,000,000 increase expense budget line A9950.59000.F0015 (Interfund Transfer-ARPA)
- (iii) \$1,000,000 increase revenue budget line H.45031.F0015 (Interfund Transfer-ARPA)
- (iv) \$1,000,000 increase expense budget line H3410.XXXXXX.F0015 (Fire Station Capital)

Section 2. That this Ordinance shall take effect immediately.
