## **ORDINANCE**

entitled

AN ORDINANCE TO AMEND THE 2022 CENTRAL GARAGE BUDGET FOR GAS AND DIESEL FUEL

WHEREAS, the Commissioner of DPW and Comptroller of the City of Binghamton find it proper and necessary to amend the 2022 Central Garage budget to cover the cost of gas and diesel fuel for City vehicles in an amount not to exceed \$55,000; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on July 6, 2022.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2022 Central Garage budget to cover the cost of gas and diesel fuel for City vehicles in an amount not to exceed \$55,000 as follows:
