A RESOLUTION AUTHORIZING THE MAYOR
TO ENTER INTO AN AGREEMENT WITH THE
AMERICAN CIVIC ASSOCIATION FOR USE OF
CVY46 FUNDS TO OVERHAUL THE HVAC
SYSTEM


WHEREAS, the Mayor of the City of Binghamton wishes to enter into an agreement with the American Civic Association (ACA) for use of CVY46 funds to overhaul the HVAC system at the ACA office located at 131 Front Street, Binghamton, New York 13905; and

WHEREAS, the estimated cost for such services is not to exceed \$150,000.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session does hereby:

RESOLVE that the Mayor of the City of Binghamton, or his designee, is hereby authorized to enter into an agreement, approved as to form and content by the Office of Corporation Counsel, with the ACA for use of CVY46 funds to overhaul the HVAC system, at a cost not to exceed \$150,000; and that funds shall be deducted from budget line CD8760.535006.CVY46 (EDW-PROGRAM-NONPROFIT ASST) for this purpose.
