A RESOLUTION AUTHORIZING THE MAYOR TO AMEND AN AGREEMENT WITH THE FIRST WARD ACTION COUNCIL FOR USE OF CDY46 AND CDY47 FUNDS TO SUPPORT AFFORDABLE HOUSING DEVELOPMENT

WHEREAS, pursuant to Permanent Resolution 21-31, dated April 21, 2021, City Council authorized the Mayor to enter into agreements with various agencies for use of FY46 CDBG funds; and

WHEREAS, pursuant to Permanent Ordinance 21-60, dated July 14, 2021, as amended by Permanent Ordinance 21-166, dated December 22, 2021, authorizing the submission of the FY47 annual action plan; and

WHEREAS, pursuant to Permanent Resolution 22-24, dated March 9, 2022, City Council authorized an extension of the agreement with First Ward Action Council from December 31, 2021, to June 30, 2022; and

WHEREAS, the City of Binghamton wishes to further extend the contract date to August 31, 2022; and to add additional funding from CDY47 for senior home repairs in the amount of \$42,402, and amend the agreement accordingly.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session does hereby:

RESOLVE that the Mayor of the City of Binghamton, or his designee, is hereby authorized to enter into an amended agreement, approved as to form and content by the Office of Corporation Counsel, with the First Ward Action Council to further extend the agreement to August 31, 2022; and to add additional funding from CDY47 for senior home repairs, at a cost not to exceed \$42,402, and amend the agreement accordingly; and that funds shall be deducted from budget line CD8668.533531.CDY47 (SENIOR REPAIR PROGRAM) for this purpose.
