MINUTES

Regular Meeting

April 12, 2022 2:00 PM, Mayor's Conference Room

Attending: R. Lake, D. Maerkl, B. Seachrist, C. Shager, A. Friedman, S. Resciniti Staff: J. Boyd

Comptroller Shager called the meeting to order at 2:02 PM and said Mayor Kraham could not attend the meeting because of another conflict. He asked for approval of the minutes from the March 22, 2022 Special Meeting. R. Lake motioned, D. Maerkl seconded and the minutes were approved (6-0-0).

1st Quarter Financial Report: C. Shager presented the 1st Quarter Statement of Activities. He said the agency had total income of \$2,235,304 of which \$2,152,300 was from Empire State
Development, a grant for the 7 Hawley Street Parking Ramp. He said that money was transferred to the City to pay for the garage. There was \$83,000 of Other Grant income from the City of
Binghamton which was \$50,000 that was budgeted and another \$33,000 which he had requested from City Council and they approved and it was moved into this account. Under expenses, the audit was \$2,500, Stadium Expense so far had been \$25,000, and the Grant Operating Expense was \$2,152,300 resulting in a Change in Net Assets of \$55,147 that increased the agency's Net Assets –
Ending to \$514,924. Moving to the Statement of Net Position he said the agency had Cash & Cash Equivalents of \$75,492 of which the agency had to have a minimum of \$20,000 on hand. He said the land value was \$439,432. The agency had a Net Position of \$514,924 with Non-spendable of \$439,432, Temporarily Restricted of \$20,000 and Unassigned of \$55,492. C. Shager said following up the discussion at the last meeting, the auditors advised indicating that the revenue from the State ESD grant came into the City's capital fund; following their recommendation, next year's report they will indicate that the money came in 2022.

New Business:

Appointment of Members to ABO Required Committees: J. Boyd said BURA was classified as an authority by the NYS Authorities Budget Office and all State authorities are required to staff Committees for Governance, Audit, Finance and Strategic Priorities with Board Members:
